### **Exhibition Policies**

Artists may not show the same piece of artwork more than once at the CCC without prior consent.

The CCC reserves the right to decline individual items within a particular group exhibit.

Artwork must be appropriately matted, framed or otherwise presented and ready to hang or display in a case. Artwork or other display pieces cannot be removed from the premises during the exhibit period.

The CCC is not liable for the security of or damages to artwork dropped off or picked up before or after designated times. Works left behind longer than two weeks after the designated pick-up time become the property of the CCC.

Artists warrant originality and ownership of the artworks and that the art works will not infringe upon any copyright, right of publicity, moral right, or any proprietary or other right of any third party. The artist warrants that he/she has not used any copyrighted or licensed material (text or visual images) in the art works or in the making of said artworks without the express written permission of the owners of those rights.

Artists will indemnify and hold harmless the CCC and anyone deriving his or its interest from, through or under the CCC from and against any claim, suit, action, liability or expense (including reasonable counsel fees) arising out of any matter or claim which would result from presentation of the artist's artwork at the CCC or through using images of the artwork for publicity/advertising purposes.

### **Exhibition Concept**

The annual Members' Exhibit is an exhibit and sale of original works by Members of the Cedarburg Cultural Center. The exhibit features works of all styles, themes and media. CCC Members may each submit up to two original artworks. Accepted media may include but are not limited to: painting, sculpture, photography, jewelry, ceramics, fiber, drawing and mixed media. 2D works must be ready for installation with framed or painted edges and fitted with hanging wire. (No sawtooth hangers without prior permission, please.) Works should be clearly labeled on the back with the artist's full name, title of the artwork, medium and price. 3D work must stand firmly on its own if not mounted to a base.

### **Sales/Commission**

The Center will retain a commission of 35% on all sales. All work must be priced or labeled "Not for Sale" (NFS). No price or title changes may be made after entry.

### **Entry Fee**

CCC Members may enter the exhibit free of charge. Non-members must join the CCC to participate. Memberships must be current for the duration of the exhibit.
